### **NHS Rotherham Single Integrated Plan: Submission and stakeholder consultation timetable**

NHS Rotherham's Single Integrated Plan (SIP) is a refresh of Better Health, Better Lives in the context of the NHS Operational Plan 2011/12 requirements and the SHA's timetable to achieve sign off of Yorkshire and Humber's SIP by the DH in mid May.

NHS Rotherham's SIP will be made public in mid May and form the basis of ongoing dialogue with the public, RMBC and providers about how to continue to deliver Better Health, Better Lives.
